

Rules and Regulations:

2022 Official Rules:

NO PURCHASE NECESSARY TO ENTER OR WIN. INTERNET ACCESS AND E-MAIL ACCOUNT REQUIRED. OPEN ONLY TO LEGAL RESIDENTS OF CANADA (EXCLUDING QUEBEC), 18 YEARS OF AGE OR OLDER WHO HAVE A SCHOLASTIC READING CLUB TEACHER ACCOUNT. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

Eligibility

"Scholastic Reading Club's Win a Free Book For Every Child in Your Class Giveaway!" (the "Giveaway") is open only to legal residents of Canada (excluding Quebec) who are 18 years or older at time of entry ("participants" or "entrants") and who have a Scholastic Reading Club Teacher Account. If you do not currently have a Teacher Account, please go to www.scholastic.ca/readingclub to create an account. There's no charge to open an account. DO NOT PARTICIPATE IN THE GIVEAWAY IF YOU ARE NOT A LEGAL CANADIAN RESIDENT 18 YEARS OR OLDER. Employees, officers, and directors of Scholastic Canada Ltd. ("Sponsor"), its affiliated and subsidiary companies, advertising and promotional agencies, and suppliers of promotion materials and services and any other entity engaged in any way in the development, production, printing, distribution, or execution of the Giveaway, and members of the immediate family or household of such individuals are not eligible. By entering, you acknowledge and agree that Sponsor may, but is not obligated to, publish or post any or all responses, whether selected as a winner or not, in its Reading Club flyers or other materials, on its website(s) or any of its pages on any other site(s), including, but not limited to, social media sites such as Facebook and Twitter, and may be used for any other legal purpose, including, without limitation, advertising in any and all media.

Prizes:

Twenty five (25) winners will each pick one title for their entire class to receive, up to a maximum of 36 copies (ARV \$150). Titles may vary from the ones indicated in the April teacher flyer.

Giveaway Drawings

Drawing will be conducted by Sponsor on or about May 6, 2022 . Odds of winning a prize depend on the number of eligible entries received. Sponsor will announce the winners on the Scholastic Reading Club contest page: [scholastic.ca/rc/contestsandactivities](https://www.scholastic.ca/rc/contestsandactivities) and contact winners directly via e-mail. **If chosen as a potential winner, entrant will have to answer a skill based question in order to win.** Sponsor reserves the right, in its sole and absolute discretion, to disqualify any submission that is inappropriate for any reason, including, without limitation, for depicting or mentioning sex, violence, drugs, alcohol, and/or inappropriate language.

Entry Restrictions
